Your request has been handled as a request for information under the Freedom of Information Act 2000 (the Act).

A search for the requested information within AWE has now been completed, and we can confirm that information in scope of your request is held.

We are able to disclose the some of the bands/grades/salaries of the positions as requested.

However some of the salaries have been redacted and withheld under section 40 of the FOI Act. This section provides that information can be withheld where disclosure would constitute personal data. This exemption applies if releasing the information would breach any of the data protection principles outlined in the Data Protection Act. We have engaged Section 40 of the Act in this instance due to the fact that there are a small number of individuals or a single individual occupying some of the roles. Consequently, disclosing any information pertaining to these roles could potentially lead to the identification of these individuals. This measure is taken to ensure the protection of personal data and to uphold privacy standards, as releasing such information could inadvertently reveal the identities of the individuals involved.
