Your request has been handled as a request for information under the Freedom of Information Act 2000 (the Act).

We can confirm that AWE holds all of the requested information; however sections 22(1)(a)(b)(c); 'Information Intended for Future Publication' exemptions have been applied to the data thereby exempting its release.

AWE has reviewed your request for information under the Act and applied Section 22(a)(b)(c); 'Information intended for Future Publication'.

Section 22(a): The information is held by the public authority with a view to its publication, by the authority or any other person, at some future date (whether determined or not).

Section 22(b): The information was already held with a view to such publication at the time the request for information was made, and



Section 22(c) It is reasonable in all circumstances that the information should be withheld from disclosure until the date referred to in paragraph (a).

Section 22 is a qualified class-based exemption and consideration must be given as to whether there is a public interest in providing the information prior to the anticipated publication.

AWE is committed to recognise there is a strong public interest to demonstrate openness, transparency and accountability with regards to the Freedom of Information legislation particularly in relation to an individual's right to know. We recognise that disclosure would provide reassurance that AWE is processing the requests that it receives in a timely manner particularly as it would indicate how we are meeting our obligations as outline in the provisions of the Act.

Considerations favouring Non-Disclosure; AWE is committed to publishing information however we do not consider that it is in the public interest to place information into the public domain, prematurely, before pre-publication procedures have taken place. We have therefore reached the view that, on balance, the public interest is better served by withholding this information under Section 22 of the Act at this time.
